### 4. First Aid

#### General Information

If medical advice is needed, have product container or label at hand. You should call the National Poisons Centre if you feel that you may have been harmed or irritated by this product. The number is 0800 764 766 (0800 POISON) (24 hr emergency service).

**Recommended first aid facilities** Ready access to running water is recommended. Accessible eyewash is recommended.

#### Exposure

**Swallowed** IF SWALLOWED: Call a POISON CENTRE or doctor/physician if you feel unwell. Rinse mouth. Do NOT induce vomiting. Give a glass of water to drink.

**Eye contact** IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

**Skin contact** This product is non-irritating to skin. No further measures should be required.

**Inhaled** Generally, inhalation of fumes/vapours/dusts is unlikely to result in adverse health effects. ### 5. Firefighting Measures

**Suitable extinguishing substances:** Carbon dioxide, extinguishing powder or water jet. Fight larger fires with water jet or alcohol resistant foam.

### 6. Accidental Release Measures

**Containment** In all cases design storage to prevent discharge to storm water.

**Emergency procedures** If a significant spill occurs:  
Stop leak if safe/necessary; Isolate area. Collect spill – see below; Transfer to container for disposal. Dispose of according to guidelines below (Section 13).

**Clean-up method** Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

**Disposal** Mop up and collect recoverable material into labelled containers for recycling or salvage. Recycle containers wherever possible. This material may be suitable for approved landfill. Dispose of only in accord with all regulations.

### 8. Exposure Controls / Personal Protective Equipment

#### Workplace Exposure Standards

A workplace exposure standard (WES) has not been established by WorkSafe NZ for this product. There is a general limit of 3mg/m<sup>3</sup> for respirable particulates and 10mg/m<sup>3</sup> for inhalable particulates when limits have not otherwise been established.

#### Engineering Controls

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. Exposure can be reduced by process modification, use of local exhaust ventilation, capturing substances at the source, or other methods. #### Personal Protective Equipment

##### General

##### Eyes



Avoid contact with eyes. Use safety glasses and or chemical splash goggles if splashes are possible or handling this material in bulk. Select eye protection in accordance with AS/NZS 1337.

##### Skin

Protective gloves and clothing are not normally necessary. However, it is prudent to wear gloves when handling chemicals in bulk or for an extended period of time.

##### Respiratory

A respirator when airborne concentrations approach the WES (section 8). Respirators must have filters appropriate to the duty and comply with AS/NZS1716 and selected, used and maintained in accordance with AS/NS 1715. Use a 'ENTER RESPIRATOR TYPE'. If using a respirator, ensure that the cartridges are correct for the potential air contamination and are in good working order. Fit testing and clear guidelines and training for use and maintenance of PPE are necessary.
